Matters of Interest

The son was angry as his father was refusing to transport him to the hospital to get checked out. Police and first responders attended and the son was determined to be fine.
- 3) On the 26th of June 2020 at 5:18 pm in Gillies Township police received an ambulance assist call in regards to a 94 year old male with a suspected bladder infection. The male was threatening to cut his throat with a chainsaw as he was in a lot of pain. Officers determined there were no weapons in the residence and the male was not actively trying to harm himself.
